General training related to Guardian ad Litem's duties: 66.5 hours +10 hours practicum to include Strengthening Advocacy Through Quality Report Writing, Ethics and Professional Conduct for Family Law GAL, Law and Legal Process, Family Law GAL investigations, interviewing adults and children, chemical dependency/mental illness, child abuse and neglect, domestic violence, cultural competency, enhancing relationships through teaming, mental health issues in children, previously served as CASA.

Specific training related to issues potentially faced by children in dissolution, custody, paternity, and other family law proceedings: 60+ hours to include Adverse Childhood Experiences, From ACE to Action to help traumatized children, Right Response training, multiple training hours regarding substance abuse, report writing, mental health issues in children and adults, parenting classes, grieving, HIPPA and Privacy training, communication classes, Power of Positive Thinking. Continue to pursue education and knowledge through on-line classes, books or published material regarding family law cases and the effects of conflicts in those cases on children.

Seventeen years of hands on training with special needs and medically fragile children.
