Do You Satisfy the Legal Requirements for Sealing Juvenile Offender Court Records?

In Washington, the Juvenile Court in the county where you were charged can order the sealing of your juvenile offender court record, but only if you meet the legal requirements described in the following chart. Review the requirements.

Please note that you are required to pay a \$75.00 non-refundable processing fee (cash or money order) to begin this process. It is your responsibility to determine if you meet the criteria.

You must be at least 18 years of age at the time of this request and your offense must have been committed in Benton or Franklin Counties.

If you have marked **NO** on all of the questions below you may proceed with your request to seal your juvenile records.
