- has exhibited a serious substance abuse problem; or
- has exhibited behaviors that create a risk of serious harm to the health, safety, or welfare of the child or any other person; or
- c.  the child is in need of necessary services (including food, shelter, health care, clothing, education, or services designed to maintain or reunite the family); the child lacks access to, or has declined to utilize these services; and the child's parents have evidenced continuing but unsuccessful efforts to maintain the family structure or are unable or unwilling to continue efforts to maintain the family structure.
- d.  the child is a "sexually exploited child."
- e.  the requirements of RCW 13.32A.140 are met.

1.6 The allegation that the child is in need of services is based on the following facts:

- 1.7 A serious conflict exists between the parent and child.
- a. The petitioner has made a reasonable effort to resolve the conflict.
  - b. Reasonable efforts have been made to prevent or eliminate the need for removal of the child from the child's home and to make it possible for the child to return home.
  - c. A suitable out-of-home placement resource is available.

**II. RELIEF REQUESTED**

I request that the Court order out-of-home placement of the child.
